



2027 CHARITY PARTNER PROGRAM OVERVIEW

PURPOSE

At Grandma's Marathon, we believe in the power of transformation. It begins the day you register and grows every morning you lace up those shoes and step out the door. Our Charity Partner Program encourages runners to share that life-changing experience by making a difference in someone's life as they transform their own. Non-profits selected to become Official Charity Partners have the opportunity to raise awareness as well as vital funding for their causes by offering guaranteed entries into Grandma's Marathon race weekend events.

FUNDRAISING PLATFORM

Grandma's Marathon has partnered with Race Roster to provide a fundraising platform for the Charity Partners Program. This platform is available to all Charity Partners as an optional means for collecting donations and recruiting runners via a customizable account page. If your organization uses Race Roster as its fundraising platform, your runners will have access to their own personal fundraising pages where they can designate funds raised to go to your charity. Race Roster will distribute collected funds to Charity Partners on a weekly basis.

Charities may use their own platform for fundraising but must submit fundraising totals following the event to Grandma's Marathon.

CHARITY PARTNER ELIGIBILITY AND REQUIREMENTS

- Charity must be a registered 501(c) (3) non-profit organization.
- Charity commits to purchasing a minimum of (5) race entries of any combination.
- Charity agrees to provide Grandma's Marathon with its logo, a description of the charity, its mission, its runner fundraising guidelines and minimums, and the URL for its fundraising platform (if not using Race Roster) prior to September 15 2026. This information will be posted on the Grandma's Marathon website.
- Charity will maintain regular and frequent communication with its current runners and potential runners regarding fundraising guidelines and deadlines. Runner instructions must note that all charity runners are required to officially register for the marathon, half marathon, or 5K by following the provided charity registration instructions and correctly using the charity code by 11:59 p.m. CDT on May 6, 2027. No exceptions.
- Charity is responsible for submitting a report to Grandma's Marathon regarding its total of funds raised through the program by July 9, 2027.
- Charity must review the 2027 timeline chart and agree to meet all deadlines.

GRANDMA'S MARATHON CHARITY LEVELS & BENEFITS

Charities must commit to a level during the application process. Each charity then has the flexibility to choose how many bibs it would like within the level guidelines and the number of bibs for each race it would like to purchase. Charities that would like to upgrade levels from the initial commitment will only be allowed to do so based on availability of bibs. CHARITY BIB PRICING

Charity Partners are able to pre-purchase guaranteed race entries at the lowest registration rate offered. A minimum of (5) race entries must be pre-purchased (combination of 5K, half, or full). Michelina's All-You-Can-Eat Spaghetti Dinner tickets are also available for pre-purchase. *All purchases are final.*

MARKETING AND PROMOTION

- All charities are provided with a page on the Grandma's Marathon website to highlight their mission, fundraising minimums, and additional incentives.
- Each charity is responsible for its own marketing and promotion to recruit runners.
- Grandma's Marathon will promote the Charity Runner Program as a whole and will give charities opportunities to be spotlighted as they arise.
- After event sell outs all charities will be promoted via email, social media, etc.

FUNDRAISING REQUIREMENTS

Each charity can set it's own fundraising minimum as long as it is not less than the following: Grandma's Marathon, Garry Bjorklund Half Marathon – \$500; William A. Irvin 5K – \$250. **If you would like to apply for an exemption, please email alivia@grandmasmarathon.com.*

Charities are responsible for entering into a fundraising agreement with each runner.

CHARITY RUNNER INCENTIVES

Charities are encouraged to provide additional incentives to runners who raise above and beyond their fundraising minimum. Grandma's Marathon will provide the following incentives to runners who hit these fundraising levels:

Charities with runners meeting this threshold should reach out to Program Director Alivia Nelson via email at alivia@grandmasmarathon.com on a rolling basis but no later than June 1, 2027.

CHARITY RUNNER REGISTRATION

Charities receive a designated registration code and instructions to distribute to its runners. Charity runners must use the code provided and register via Race Roster by May 6, 2027 in order to officially participate in Grandma's Marathon race weekend.

PLEASE NOTE FOR RUNNERS: Any additional registration options or fees associated with a runner's failure to use registration instructions and code correctly will not be reimbursed.
